

**THE TOWN OF MOUNT AIRY  
ORDINANCE NO. 2020-9**

AN ORDINANCE TO AMEND ORDINANCE 2019-3, WHICH ADOPTED AND APPROVED THE BUDGET FOR THE TOWN OF MOUNT AIRY FOR FISCAL YEAR 2019-2020.

FOR THE PURPOSE OF AMENDING THE BUDGET BY REMOVING \$675,000 FOR THE WINDY RIDGE PARK ACCESS PROJECT ALONG WITH THE OFFSETTING REVENUE FROM THE GENERAL FUND CAPITAL BUDGET.

WHEREAS, the Windy Ridge Park Access Project was included in the budget for Fiscal Year 2019 - 2020; and

WHEREAS, the project has not moved forward as planned and preliminary work is in process in Fiscal Year 2019-2020; and

WHEREAS, the bulk of the project will be included in the budget for Fiscal Year 2020 – 2021; and

WHEREAS, the Town Council wishes to amend the budget for Fiscal Year 2019 – 2020 in order to keep the budget document as accurate as possible; and

WHEREAS, the Town Council of Mount Airy Adopted Ordinance 2019-3 adopting the Budget for Fiscal Year 2019-2020 for the Town of Mount Airy on May 6, 2019; and

WHEREAS, the Town Council wishes to amend Ordinance 2019-3 as follows:

NOW THEREFORE, BE IT RESOLVED that the Town of Mount Airy Budget for Fiscal Year 2019-2020 be, and hereby is, amended to remove \$675,000 from the Parks & Playgrounds Capital Projects line item along with the funding from a DNR Project Open Space Grant partnered with Frederick County in the amount of \$675,000; and that all other provisions of Ordinance 2019-3 shall remain unchanged and as is.
